With these facts in mind, I voluntarily assume the risk of participating in any activities on the SMF fair grounds. There have not been any express or implied representations to me on behalf of SMF except as set forth in this Agreement.

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court or competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

I hereby grant STEAMMaker.org full and complete permission to use photographs, videography and interview footage and quotations from me, and the children under my care, in legitimate promotions and to further the mission and vision of SMF in any and all media now known or hereinafter developed without restriction or compensation.
